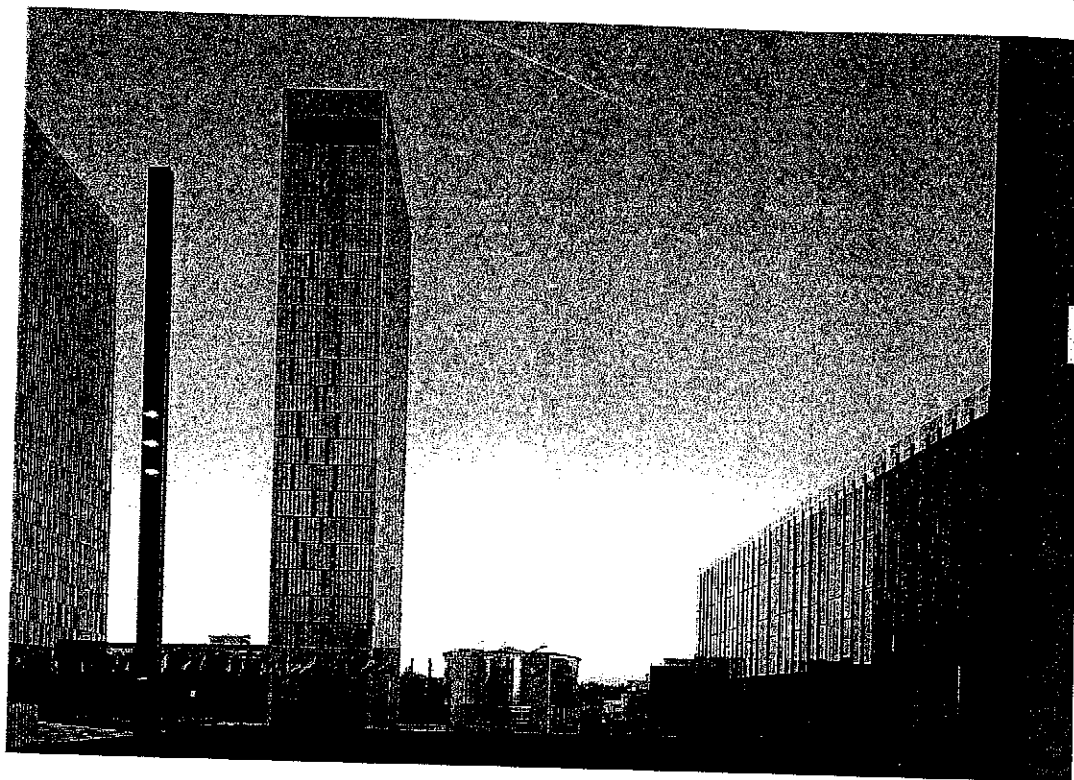

Admissions to the two-days training seminar on the “**EU Charter Rights**” (8-9 April 2016), organised by the European Inter-University Human Rights and Democratisation (EIUC) are open until 18

The object of this training seminar is to explore the scope and application of the Charter for the legal practitioners facing the national courts of the EU, mostly by means of preliminary reference. Beyond the features of the Court and essential aspects of its functioning, the seminar will be dedicated to the analysis of relevant case law in parallel with a view to allow discussion and exchange on specific concrete issues which: • Privacy/Data Protection • Internal Market • Asylum and Economic and Social Rights.

The seminar will focus on the Charter's values, as well as on their application when a specific appeal is submitted. The academics composing the Training seminar's faculty are high level well-known and leading professors coming from different European Universities.
